### **Principals' Report**

**Staff Training Opportunities** - Dawn Priesler highlighted opportunities for reading support and ELA coaching, as well as developing the ACT 20 plan and EL support with CESA. The literacy program is on track to start by July 1, 2025. Nicole and Jon are working on website accessibility to meet the 2027 deadline. A board member expressed enthusiasm about leading the initiatives at AHS. The hybrid model for small groups has proven effective, and recent conferences went well, positively impacting students.

**School Happenings and Activities** - Jeff Allen spoke on the topic of communication, referencing methods such as the Reaching Out Newsletter, SBS Snapshot, video messages, and social media with academic depth. The Monster Bash was a success, and we want to give a shoutout to the PTO. A board member raised concerns over charging \$30 for an in-school event. The school musical and a school assembly are taking place this week. Looking ahead, Finance Park and the Food Drive are coming up.
